Mission

The City of San Angelo Development Corporation, working with economic development partners, will retain, strengthen and diversify the job base of the community to ensure a vibrant business climate for San Angelo and the region.

Organization

The City of San Angelo Development Corporation (COSADC) is a non-profit economic development corporation formed under the Texas Development Corporation Act of 1979. As directed by the Act, COSADC focuses its efforts on the promotion and development of business enterprises that create or retain primary jobs.

The COSDC is responsible for administrating the local economic development sales tax incentive awards, as well as managing the contracts regulating them. To maximize the effectiveness of local economic development resources, COSADC partners with other business assistance partners: San Angelo Chamber of Commerce, Concho Valley Center for Entrepreneurial Development, Downtown San Angelo, Inc., the Small Business Development Center at Angelo State University, Howard College and the West Texas Training Center, and the Concho Valley Workforce Board and Workforce Solutions of the Concho Valley.

Leadership & Staff

The COSADC is governed by a seven member board of directors, and four city staff members are assigned to assist the COSADC board and carryout the day-to-day operations for the organization. Shawn Lewis serves as the Executive Director and also directs the Community and Economic Development department for the City of San Angelo. Robert Schneeman serves as the Development Coordinator, and also coordinates the Development Review Committee process for the City. Donna Osborne serves as the Economic Development Coordinator, and also directs the operations of the Concho Valley Angel Network (CVAN) and CVCED – The Business Incubator. Nora Regino serves as the Senior Administrative Assistant for the COSADC and the Community and Economic Development department for the City.

Vision

COSADC serves as the economic development arm of the City of San Angelo and develops policies and implements strategies which align with the vision established by City leaders. The following key goals drive the business and recruitment efforts:

- Increase partnerships with institutions of higher learning to retain and attract an educated workforce
- Facilitate coordination between taxing entities related to incentives and advocacy on common issues
- Promote increased business development opportunities at the San Angelo Regional Airport
- Monitor the cost of doing business in San Angelo
- Capitalize on alternative transportation modes
- Implement a strategic plan for business recruitment and assistance, and match community assets to emerging industries
- Adequately maintain infrastructure to support business attraction and growth
